

ADVERTISEMENT FOR BIDS

Two Rivers Public Health Department will receive sealed bids for design/construction of Suites #104 & 108 at Two Rivers Public Health Department, 516 West 11th Street, Suite 104, Kearney, Nebraska, which is located in Buffalo County, Nebraska. The project is inclusive of all necessary requirements for design and construction.

Bids for this project will be accepted until 4:00 PM Central Time, Monday, October 4, 2021 at the office of the Two Rivers Public Health Department, 516 West 11th Street, Suite 104, Kearney, Nebraska 68845. Bids will be presented to the Two Rivers Public Health Department Board of Health during their regular meeting commencing on Tuesday, October 5 at 6:00 PM, at which time and place all bids will be opened and read aloud.

The work required for the project is briefly described as follows:

DEMOLITION AND RECONSTRUCTION OF SUITES #104 & 108 INCLUDING ALL MATERIALS AND LABOR

Construction Drawings and Specifications will be on file in the office of the Two Rivers Public Health Department and available on our website, www.trphd.org. Copies may be obtained from the Two Rivers Public Health Department office.

A pre-bid conference and site inspection will be provided by Two Rivers Public Health Department. Prospective bidders shall meet at the Two Rivers Public Health Department office at 10 AM, Tuesday, September 28, 2021. The deadline for questions regarding bid specifications will be October 1, 2021.

Envelopes containing the bids shall be sealed and must be accompanied by a certified check or bidder's bond in an amount of not less than five percent of the amount bid. The check or bond shall be made payable to the Two Rivers Public Health Department as security that the bidder to whom the award is made will enter into a contract to build the improvements bid upon and furnish the required bond. No bids shall be withdrawn after opening the bids without consent of the Two Rivers Public Health Department for a period of thirty days after the scheduled time for closing bids. Two Rivers Public Health Department reserves the right to reject any or all bids and to waive any formalities in bidding.

The successful bidder shall supply a Performance and Payment Bond executed by a Corporate Surety licensed in the State of Nebraska in an amount equal to 100% of its contract price.

Upon acceptance of a bid a Notice of Award and contract will be issued. The bidder will execute the Two Rivers Public Health Department standard contract for services within fifteen days from the date of the Notice of Award. A Notice to Proceed will then be issued, after which substantial completion of the work shall be achieved within 60 days of mobilization to the project site and no later than December 31, 2021.

No alternative items will be considered.
